Hazardous waste

Poisonous substances in the residual waste bin or in the sewer system may endanger health and environment! Please bring such waste separately collected to the household hazardous waste collection vehicle or to the FNE interim storage facility for hazardous waste in Freiberg, Am Schlachtweg 6.

The following is part of hazardous substances

- | Energy saving lamps and halogen bulbs, fluorescent tubes
- | Mercury thermometers
- | Batteries and rechargeable batteries, car batteries
- | Varnish, nitro lacquer, alkyd lacquer and the respective paints
- | Household chemicals, photographic chemicals, adhesives
- | Paint strippers and wood preservatives
- | Fertilizers
- | Stain removers, solvents and disinfectants
- | Expired pharmaceuticals
- | Plant protecting agents and pesticides
- | Oils and containers with unknown content etc.

The following is not part of hazardous substances but belongs into the

Residual Waste Bin

- | Dried paints and color cartridges

Yellow Bin

- | Empty paint canisters

Waste glass

Please separate the empty glass bottles and jars according to colors: green, brown and white. Blue bottles belong to the green glass.

The following belongs into the Bottle Bank

- | Juice, wine, sparkling wine, oil and ketchup bottles made of glass
- | Vegetable jars, jam jars and preserving jars
- | Jars for baby food

The following does not belong into the Bottle Bank but into the

Residual Waste Bin

- | Lead glass, sintered glass and heat-resisting glass
- | Window and mirror glass
- | Ceramics and china
- | Light bulbs

Used paper

Used paper and cardboard are an important raw material. But they may only be recycled when they are clean.

The following belongs into the Blue Bin

- | Journals and magazines
- | Writing and print-out paper
- | Catalogs and advertising brochures
- | Crumpled paper
- | Books without coated cover
- | Packaging paper and cardboard packaging

The following does not belong into the Blue Bin, but into the

Residual Waste Bin

- | Polluted paper and cardboard
- | Photographs, folders
- | Diapers
- | Wallpaper remnants (even unused)

Yellow Bin

- | Composites (Tetra Pak) and aluminum foils
- | Coated paper from sausages and pastries
- | Coated cardboard from deep-frozen food
- | Disposable tableware made of cardboard

Organic Waste Bin

- | Paper towels, cleansing tissues and tissue handkerchiefs



Lightweight packagings

These are used sales packagings made of plastics, aluminum, tinfoil or composites (Tetra Pak)

The packagings have to be empty - rinsing is not required!

The following belongs into the Yellow Bin

- | Plastic bottles of detergents, rinsing agents and cosmetic products
- | Cups of yoghurt, curd cheese and other milk products
- | Bowls for fruits and vegetables made of styrofoam or wood
- | Lids, bowls, cans, partitioned plates made of aluminum
- | Liquid packaging boards (Tetra Paks)
- | Empty aerosol cans, crown caps, caps
- | Styrofoam packagings
- | Empty paint buckets
- | Screw caps and vacuum packs

The following does not belong into the Yellow Bin, but into the

Residual Waste Bin

- | Residual waste, diapers
- | Non-packagings made of plastic such as bowls, toys, toothbrushes, buckets, tubes
- | Insulating styrofoam

Bulky Waste

- | Garden furniture

Bottle Bank

- | Glass bottles



Biological waste

The following belongs into the Organic Waste Bin

- | Fruit and vegetable leftovers
- | Tea bags and coffee filters
- | Eggshells and nutshells
- | Flower and plant remains, lawn-clippings
- | Foliage, and shredded hedge clippings, tree prunings and bush clippings
- | Compostable bedding



The following does not belong into the Organic Waste Bin, but into the

Residual Waste Bin

- | Fish, meat and sausages leftovers
- | Diapers, vacuum cleaner bags and leftover tobacco
- | Ashes and sweepings
- | Non-compostable bedding, wools, animal hairs and feathers
- | Sick plants

Yellow Bin

- | Plastic bags



Residual waste

The following belongs into the Residual Waste Bin

- | Ashes and sweepings
- | Fish, meat and sausages leftovers
- | Diapers, sanitary products, vacuum cleaner bags and leftover tobacco
- | Wallpaper remnants (even unused), photographs and folders
- | Broken china and broken ceramics, broken mirror and window glass
- | Packagings with residues
- | Light bulbs
- | Non-packagings made of plastic such as bowls, toys, toothbrushes, buckets, tubes

The following does not belong into the Residual Waste Bin, but into the

- Hazardous waste collection/ household hazardous waste collection vehicle
- | Energy saving lamps and halogen bulbs, fluorescent tubes
- | Mercury thermometers
- | Batteries and rechargeable batteries

Bulky Waste

- | Residual waste that is too big for the waste bin
